SIX FLAGS MAGIC MOUNTAIN ADDS 16TH COASTER TO ITS RENOWNED COLLECTION



LAUNCHES INTO ACTION SATURDAY, MAY 23

Valencia, CA – May 21, 2009 – Six Flags Magic Mountain unveiled the latest addition to its supreme coaster dynasty today with the debut of **Terminator® Salvation™: The Ride**. This wooden marvel opens to the public on Saturday, May 23, combining innovative thrill technology with the signature science fiction punch of the *Terminator Salvation™* brand.

The newest addition to the park's world famous coaster collection coincides with the release of the McG directed film, *Terminator Salvation™*, and introduces fans to an entirely new universe inspired by the film's post apocalyptic setting. Developed by the same team that produced last year's new X2 experience, **Terminator® Salvation™: The Ride** will feature synchronized on-board audio, a loading station "fly-thru," two tunnels and fire and fog special effects. The \$10 million coaster, engineered exclusively for the Valencia theme park by Great Coasters International Inc. (GCII), **Terminator® Salvation™: The Ride** will feature Millennium Flyer coaster trains that zip through five belly-flopping hills and six high speed banked turns over 2,850 feet of track to create a ride that delivers the acrobatic thrills of a modern roller coaster while retaining the nostalgic look and feel of a classic "woodie."
