I accept this Music Scholarship with the following music department stipulations:

1. You must major in music. You may not hold a music scholarship while majoring in another field. However, majors in other areas may apply for a "Performance Award."
2. This scholarship is granted by the music faculty and is subject to review at any time.
3. Music scholarships are renewable each year up to four years. Scholarship recipients must do a jury each semester except the one in which a junior or senior recital is completed.
4. You must enroll in private lessons in your performance area («Concert») and make appropriate progress.
5. You must enroll in a one unit performance ensemble each semester.
6. You must make appropriate progress toward your degree program, including your work in music theory, piano proficiency, and other related courses.
7. You must carry a minimum of twelve units per semester with a cumulative GPA of at least 2.50 in courses taken at PLNU and GPA of at least 3.00 in music courses. A grade of "F" or "NC" in a music course is an automatic disqualification.
8. All award recipients are expected to perform service to the music department that is commensurate with the size of the award. This service is to be performed in addition to the ensemble participation and applied study stipulated by the award contract. Such service could include, but is not limited to, accompanying (ensemble or studio), ushering for performances, assisting at concerts or lectures, or providing assistance with the operation of the music department office.
