Closed approximately 100 domestic & international acquisitions with annual revenues of over \$3 billion plus over 30 investments, divestitures, and joint ventures. Formalized an acquisition process, developed training curriculum, and provided acquisition training and presentations to line and corporate staff. Featured speaker and panel member at many M&A conferences and as a member of The Conference Board's Corporate Development Council.

Corporate Vice President and Controller, Aerospace and Defense Systems Sector (10 years) Responsible for the financial and administrative management of an \$100 million sector. In that role, had oversight of the controllers and administrative staff of the operating groups within the sector. Major responsibilities included: Income statement and job cost reporting and management; analysis, pricing, and negotiation roles in support of acquisition candidates; working on strategic organizational planning to support continued growth; major real estate leasing activities; training; and coordination and oversight of business plans and performance. Involved in key contract proposal pricing strategies and fixed price contract proposal reviews, including the development of a cash flow analysis tool. Initiated and chaired a sector controller steering committee that supported development of company policy. Served on an ad-hoc basis on various corporate committees.
