- As Director, I took leadership in designing and implementing most of the operational aspects of International Health Partners' work (IHP). I was also involved in the building of a wide variety of partnerships with the various stakeholder groups with whom IHP works – most prominently in working with the UK pharmaceutical industry to initiate and develop ways in which UK pharmaceutical companies could become involved more directly and sustainably in international relief and development efforts.
- In the first two years of operations, IHP distributed over £13 million of medicines and supplies (or nearly 1 million courses of treatment) in support of relief and development efforts in more than 30 countries.
