Restore International is a nonprofit human rights organization operating in Uganda, India, Somalia, Iraq and Nepal which fights for freedom, works to improve educational opportunities, and attempts to help those in need. This has been accomplished by starting a primary and secondary school for over 300 students in Northern Uganda and creating a scholarship program to give the opportunity to 50 students who are currently continuing their education by attending a University. We operate a school with 100 girls in Mogadishu, Somalia. We have also fought trafficking through investigations, surveillance, brothel raids in India and working with local law enforcement, and have brought over 200 cases to trial in Uganda. We are also operating safe houses for women and children in Uganda, Somalia and Nepal.
